
#### VENUE ZONING MAP

#### MIXED ZONE

All athletes departing the Field of Play must exit through the Mixed Zone, allowing brief interactions with the media. Mixed Zone flow will be explained to all teams during the General Technical Meeting.





## TRANSPORTATION

#### AIRPORT TO HOTEL

Participating teams and event staff (PVPA Officials, service providers, etc.) will be provided with ground transportation from DEN airport based on the travel submitted and received.

Staff will be onsite at the airport upon arrival with signage to assist teams and staff to hotel transportation.

#### HOTEL TO COMPETITION VENUE

Embassy Suites by Hilton Denver Downtown Convention Center and the Colorado Convention Center are located adjacent to each other. All event participants will commute to the venue by crossing 14<sup>th</sup> Street. The commute distance is approx. 107 meters / 351 feet), as outlined with the arrow on the below image.

#### GUEST LAUNDRY




## CATERING FOR TEAMS, OFFICIALS AND SERVICE PROVIDERS
